

MATCH PLAY:

- Official Ball: Pro Penn Green
- Forfeit Rule: Players must check-in ½ hour prior to their match time, and will be forfeited if they do not arrive by 20 minutes after their match is called
- Scoring: All divisions will be played under USAR rules
